“2007 WORLD SERIES WINNER WATCH” SWEEPSTAKES

OFFICIAL RULES - NO PURCHASE NECESSARY.

The “2007 World Series Winner Watch” Sweepstakes starts on or about 10/17/2007 and is scheduled to end 12/31/2007. Regardless of scheduled end date, Sweepstakes will officially end when all World Series Contender cards (WSCs) have been distributed, subject to the drawing entry deadline (see below).

HOW TO PLAY– Look for WSCs randomly inserted (1:36) in packs of 2007 Topps Updates & Highlights cards (while supplies last). There are a total of 95,000 WSCs; based on MLB standings as of the date of production of the 2007 Topps Updates & Highlights card set, Topps has selected the [15] MLB teams it believes have the best chance of winning the 2007 World Series.

NO PURCHASE NECESSARY. For a chance to obtain a WSC (the particular team to be selected at random from among the [15] teams with WSCs) at the same odds, send a SASE to 2007 World Series Winner Watch Sweepstakes: Game Play Request, PO Box 5155, Avoca, PA 18641, to be received by 12/3/07 VT residents only may omit return postage. Each NO PURCHASE NECESSARY game play request must be mailed separately. Only those selected will be notified (and will receive [1] randomly selected WSC) by mail. **Note: if you receive a WSC, you have not won a prize.**

RANDOM DRAWING – Only persons who have a WSC of the team that won the 2007 World Series may enter the drawing to determine the prize winner. **To enter:** complete original WSC (NOT a copy) with all required information and mail to 2007 World Series Winner Watch Sweepstakes: Entry, PO Box 5157, Avoca, PA 18641, to be received by 12/31/07. If you have more than one WSC of World Series winning team, each WSC must be mailed separately. Drawing entry subject to verification of WSC. Drawing will be conducted by Topps on or about 1/8/08. Winner will be notified by mail/phone on or about (5) days after drawing. By participating, one (if minor [as defined below], his/her parent or legal guardian) agrees to these Official Rules and the decisions of Topps, which are final and binding.
