

# SI ON CAMPUS SUPER BOWL SWEEPSTAKES 

## OFFICIAL RULES

## 1. NO PURCHASE NECESSARY. PURCHASING DOES NOT IMPROVE YOUR CHANCES OF WINNING.

2. Sweepstakes is open to legal residents of the 48 contiguous United States and the District of Columbia age 18 years or older. Employees of Sponsor, Time Consumer Marketing Inc. and all other companies owned by or affiliated with Sponsor or Time Consumer Marketing Inc. and their advertising and promotion agencies, distributors, retailers and members of those employees' families are not eligible to enter or win.
